1. **Shri KBV Vinay** had submitted an application dated 26.12.2021 seeking information under the provisions of RTI Act, 2005. Based on the inputs received from the custodian, the CPIO, LPSC, replied to the appellant vide letter No.LPSC/CPIO-RTI/2022-421/00117 dated 13.01.2022. Being not satisfied with the reply given by CPIO, appellant has submitted an appeal dated 31.01.2022 stating that 'details not provided'.

2. The appellant had sought information regarding marks secured by the applicant in the written test and skill test conducted for the post of Draughtsman B (Mech.) and cut off marks for each category. On examination of the case, it is found that CPIO had disseminated the information vide letter dated 13.01.2022. Hence, I uphold the information provided by CPIO. Now, the appellant has requested to furnish copy of answer sheet of skill test in addition to the information sought against original application. The appellant may note that seeking fresh information is not permissible/not permitted at the appeal stage, under RTI Act, 2005. However, CPIO/Custodian of records at LPSC is directed to provide the information to the appellant within 15 days from the date of receipt of this order, if the same is not exempt under any of the provisions under section (8) of the RTI Act, 2005. Accordingly the appeal stands disposed off.
3. A second appeal against this decision lies with the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067, within ninety days from the date on which this decision is received.
4. This Appeal is disposed off at Thiruvananthapuram on the 26th day of February, 2022.


2. The queries and the submissions made by the appellant have been examined in detail and the following observation has been made:


The reply furnished by the CPIO, LPSC has been perused. Reply to query No.5, 9(a) & 11 is in order. Reply to query No.7 & 8 stated that no information is held by the Public Authority. It is confirmed that the custodian of records/CPIO disseminated the information of query No.7 & 8 after verifying the records in the Vigilance Section of LPSC. If the appellant is certain that a case is pending with Central Vigilance Commission, he may directly approach CVC for getting information with regard to query No.8. Against query No.9, the appellant sought additional information, which is not permissible/allowable at appeal stage. The appeal is decided accordingly.

3. A second appeal against this decision lies with the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067, within ninety days from the date on which this decision is received.

On examination of the case, it is found that the information sought is related to developmental contract for fabrication of Semi-Cryo Engine mixing head assembly.
3. With a view to make the nation self-reliant in application of Space Science and Technology, ISRO has been continuously engaged in design and development of various complex systems required for its missions. The technology for such complex systems has to be indigenously developed as they are not easily available / obtained from elsewhere. Hence, realization of such systems is strategic in nature. One of such developmental activities embarked upon by LPSC/ISRO, is the design and development of semicryo engine for launch vehicles. The fabrication of mixing head assembly, which is one of the most important sub-systems of Semicryo Engine involves very high precision activities. Being a developmental activity, the contract contains many technical details which are interlinked with commercial terms and conditions. Since the system is strategic in nature, sharing the copy of the contract will adversely affect the interest of the nation. Further, the contract was entered into after following due procedure and sharing a copy will also affect competitive position of a third party, as the information involves commercial confidence of the third party. As per the terms & condition of the Contract, the Contractor is also bound to maintain secrecy and is prevented from disclosing any of

the details to any other person. Hence it is exempted under Sec 8(1) (a) and 8 (1) (d) of the RTI Act.

4. In view of the above, I uphold the decision conveyed by the CPIO. Accordingly the appeal stands disposed off.
5. A second appeal against this decision lies with the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067, within ninety days from the date on which this decision is received.

3. Information sought being of generic in nature, reply was furnished by CPIO, LPSC vide letter No. LPSC/CPIO-RTI/2024-40/00021 dated 04.04.2024. The reply furnished with refernce to the application is found to be in order.



3 Examination of the Appeal


On perusal of the records brought before me, I have observed that CPIO/LPSC vide letter dated 18.09.2025 had furnished a common reply to all the three queries to the Appellant that number of applications received for Technician-B (Fitter) Post No.796 advertised vide Advertisement No. LPSC/01/2025 is yet to be finalized and further processing of applications also not started. As per the provisions contained in the RTI Act, 2005, information available with the Public Authorities are only to be furnished under the RTI Act. In the instant case, the applications received online against Post Code No. 796 (Technician B- Fitter) notified vide Advertisement No. LPSC/01/2025 was not processed for arriving at category wise applications (UR, EWS, etc) and therefore, the act of the CPIO/LPSC is in order. The contention of the Appellant that he was refused access to information requested is not borne out of facts.

The Appellant may note that once the online window for capturing applications is closed, the applications received are to be integrated with the database of candidates paid application fee, submitted cast/community/gender/disability certificate, etc and spurious applications are to be rejected, so as to arrive at the exact number of applications. Further, submission of application by the candidates sponsored through State Employment Exchanges/Sainik Welfare Board is also to be integrated with the online applications received. Therefore, the total number of candidates who submitted application form for the post of Technician B- Fitter (Post No.796)- against Advertisement No. LPSC/01/2025 is not processed for arriving at the actual number category wise (UR, EWS, etc).

The contention of the Appellant that the 'provided information is incomplete, misleading or false' is not borne out of facts.

Shri Surya V, 3/53 Main Street, Pattampudur, Virudhanagar, Tamil Nadu - 626003, vide application dated 28/08/2025 had sought information regarding the validity and applicability of OBC certificates issued based on present versus permanent address, in seven queries under the provisions of RTI Act, 2005. 2 Prayer in the Appeal

Aggrieved by the above decision of the CPIO/LPSC, the Appellant preferred an Appeal dated 02.10.2025. The Appellant had stated that '*provided information is incomplete, misleading or false*'. The Appellant has also stated that all the queries raised by him fall under RTI Act.

3 Examination of the Appeal

On perusal of the records brought before me, I have observed that CPIO/LPSC vide letter dated 25.09.2025 had informed the Appellant against query Nos. 1,2,3,5,6&7, that the information sought by the applicant does not come under the definition of 'Information' under section 2(f) of the RTI Act. Moreover, LPSC is not the custodian of Information. Further against query No.4, CPIO had informed that the OBC Non-Creamy Layer Certificate for appointment to posts under Government of India issued by the Competent Authority is acceptable to ISRO. There is no separate format of OBC Non-Creamy Layer Certificate for ISRO. As per the provisions contained in the RTI Act, 2005, information available with the Public Authorities are only to be furnished under the RTI Act. In the instant case, all queries except query No. 4 does not come under the definition of 'Information' under Section 2(f) of RTI Act and, also the aforementioned queries do not pertain to LPSC. Accordingly, CPIO has informed the details sought against query No. 4 to the applicant and therefore, the act of the CPIO/LPSC is in order. The contention

of the Appellant that the "Information is incomplete, misleading or false" is not borne out of facts.

- 4 The Appellant may note that, the details/Information sought by him vide query Nos. 1,2,3,5,6 &7 do not come under the purview of definition of 'Information' under section 2(f) of the RTI Act,2005. The Department of Personnel and Training (DoPT) is the Nodal Department for the matters related to reservation for appointments. DoPT had over a period of time issued many orders on the subject and all the relevant information are available in the public domain persmin.gov.in. Other Ministries/Department cannot interpret and issue clarification on guidelines/instructions issued by the DoPT. The details sought by the appellant against query Nos. 1,2,3,5,6&7 are in the nature of seeking opinion/clarification from the Public Authority and therefore does not come under the purview of definition of 'Information'.

Against query No.4, the CPIO has replied that the OBC Non-Creamy Layer Certificate for appointment to posts under Government of India is issued by the Competent Authorities in the respective States which is acceptable to ISRO. There is no separate format of OBC Non-Creamy Layer Certificate for ISRO. As per RTI Act, the Public Authority is duty bound to provide information which is available with them and not to issue clarification/opinion/inferences on the guidelines issued by the Nodal Ministry.

A second appeal against this decision lies with the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067, within ninety days from the date on which this decision is received.

Now, the appellant has stated that she is the spouse of the employee. This Information was not provided in the application seeking Information under RTI Act.

Considering the fact that the applicant is the wife of the employee the custodian of records at LPSC is directed to provide available information to the appellant within

15 days from the date of receipt of this order , after applying severability clause under section 10(1) of RTI Act. Accordingly the appeal stands disposed off.

1. Background

Ms Rejitha S, Ajitha House, Chevidampara, Karikkuzhi, Panavoor P O, Kerala – 695568 vide application dated 23/10/2025 had sought the following information under RTI Act 2005.

1. The number of employees appointed as Technical Assistants through special review in each ISRO centres (URSC, VSSC, SAC, LPSC, IPRC, etc.) during the last 40 years. (or from the earliest period for which records are available) who were initially appointed as Technician B and later completed a Diploma in Engineering after joining ISRO.
2. Out of these how many had already completed a Diploma or B.Tech before joining as Technician B and later completed or re-acquired a Diploma in Engineering after joining ISRO, thereby becoming eligible for special review and promoted as Technical Assistant.

CPIO vide letter No. LPSC/CPIO-RTI/2025/115/00017 dated 12.11.2025 informed the applicant that, the information sought by the applicant is scattered in nature and furnished the details from 01/01/2020.

2 Prayer in the Appeal

Not satisfied with above decision of the CPIO/LPSC, the Appellant preferred an Appeal dated 15.11.2025. The Appellant has stated that '*provided incomplete, misleading or false information*'.

3 Examination of the Appeal

On perusal of the records brought before me, I have observed that CPIO/LPSC vide letter dated 12.11.2025 had furnished reply to both queries that the information is scattered in nature. However, details of Special Review to the post of Technical Assistant from 01.01.2020 was consolidated and provided. As per the provisions contained under RTI Act, 2005 Public Authorities have to furnish only 'Information' available with them. The Information sought was for 40 years and it was not compiled and scattered. It requires extensive collation of data, which

disproportionately divert the limited resources of the public authority. Therefore, the decision of CPIO to disseminate the data for last 5 years is in order.


निर्णय/DECISION

I have carefully examined the appeal preferred by the appellant. Though, the details are not maintained in physical form, it is presumed that the data may be available in Electronic form. Though, data for 40 years may not be available in Electronic form, available data may be obtained from the custodian and furnish to the Appellant within 15 days from this order.

The Appellant may note that the information provided is based on the digital records available.

A second appeal against this decision lies with the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067, within ninety days from the date on which this decision is received.

This Appeal stands disposed off with the above decision at Thiruvananthapuram on the 15th day of December, 2025.

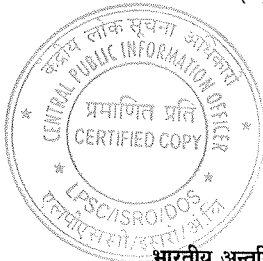

1. Background

Shri R S Reddy, Y Junction, Sullurpetta, Andhra Pradesh – 524121 vide application dated 18/10/2025 had sought the following information.

1. Any fire service personnel or cadre that needs to mandatorily reside in the residential quarters provided by the department. If so, please provide details of the following;
 - A. Provide the list of the personnel along with name, designation and cadre.
 - B. Provide the order/o.m/circular that mandates the above referred persons to reside mandatorily in residential quarters provided by the department.
2. The details of fire personnel and employees related to safety division/section that residing outside the residential quarters that provided by the department. And also, provide the details of the period of drawal and amount and percentage of House Rent Allowance(HRA) by the said personnel.
3. The order, if any, that mandates the fire service personnel and employees that related to safety division/section mandatorily resides in the residential quarters provided by the department.

Accordingly, the CPIO vide letter No. LPSC/CPIO-RTI/2025/111/00089 dated 19.11.2025 provided a common reply to both queries 1 &3 together informing that the information can be sought from the DOS. Reply to query No. 2 was furnished.

2 Prayer in the Appeal

Aggrieved by the above decision of the CPIO/LPSC, the Appellant preferred an Appeal dated 18.11.2025. The Appellant has stated that 'No response within the time limit'.

3 Examination of the Appeal

On examination of the case, it is found that information sought against query No.2 has already been furnished to the appellant vide letter dated 19.11.2025. It was also replied that the details sought vide query Nos. 1 &3 does not pertain to CPIO/LPSC and therefore Information may be obtained from DOS. Accordingly, the appeal stands disposed off.

निर्णय/DECISION

The appellant had sought information about orders, list of personnel residing both inside and outside residential quarters of Dept etc, regarding provisions of residential quarters of the department to fire service personnel and employees related to safety division. On examination of the case, it is found that information has already been furnished to the appellant vide letter dated 19.11.2025. Accordingly, the appeal stands disposed off.

A second appeal against this decision lies with the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067, within ninety days from the date on which this decision is received.

This Appeal is disposed off at Thiruvananthapuram on the 20th day of November, 2025.

1. **Background**

2. **Prayer in the Appeal**


Aggrieved by the above decision of the CPIO/LPSC, the Appellant preferred an Appeal dated 11.12.2025. The Appellant had stated that he was 'Provided Incomplete, Misleading or False Information'. The written exam date also published in website as 4/1/2026 and requested to provide how many online applications are received under all categories

3. **Examination of the Appeal**


On perusal of the records brought before me, I have observed that CPIO/LPSC vide letter dated 09.12.2025 had furnished reply to the query of the Appellant that the recruitment processes are under progress and therefore, the information sought by the applicant cannot be divulged now. As per the provisions contained in the RTI Act, 2005, information available with the Public Authorities are only to be furnished under the RTI Act. In the instant case, the applications received on online against Post Code No. 796 (Technician B- Fitter) notified vide Advertisement No. LPSC/01/2025 was not processed for arriving at category wise applications (UR, EWS, etc) and therefore, the act of the CPIO/LPSC is in order. The contention of the Appellant that he was provided incomplete, misleading or false information is not borne out of facts.

निर्णय/DECISION

The Appellant may note that recruitment activities related to the conduct of written test are under process and therefore, the information sought by the appellant can be provided once the selection panels are drawn. However, since the applications received against the advertisement are validated with reference to payment, certificates etc. CPIO may furnish the total number of applications received against the post of Technician B (Fitter)

A second appeal against this decision lies with the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067, within ninety days from the date on which this decision is received.
